**Contract Agreement for Outside Storage**

This agreement is made and executed this \_\_\_\_ day of \_\_\_\_\_, **20\_\_** by and between, **Park, Bark & Fly** and \_\_\_\_\_, being the owner of the boat, motor home, trailer and/or recreational vehicle described hereto (Hereinafter "Vehicle"). Owner desires to store said vehicle on the premises of Park Bark & Fly for a period of at least \_\_\_\_\_ or until such time that Park Bark and Fly has been notified, in writing that the owner plans on removing the vehicle from the premises.

Park Bark & Fly will automatically charge the credit card on file each month for \$ \_\_\_\_\_. Payment is due on or before \_\_\_\_\_. Owner will be charged for storage rental until written notification has been submitted to Park Bark & Fly that owner no longer plans on renting the storage space. All storage charges must be paid in full before the vehicle is removed from Park Bark & Fly property.

In consideration of storage payment, Park Bark & Fly agrees to store the vehicle as described in this agreement. There are no refunds. Park Bark & Fly has the right to change storage rates annually, from date of contract. There is a \$35.00 charge for any NSF checks. Park Bark & Fly shall have the right to retain possession of the vehicle until such time as all charges and cost incurred under this contract agreement are paid in full. Park Bark & Fly has the option to have the vehicle towed from the premises at the vehicle owner's expense.

Access to vehicle is available 24 hours weekdays and weekends by showing your access card or drivers license to booth attendant. This storage agreement covers outside storage and only the rental space sufficient to store one vehicle per space. Vehicle owner releases all claims against Park Bark & Fly property owner(s), representatives, agents and employees from any and all damage or loss to vehicle or its contents, including, but not limited to, theft, vandalism, fire, windstorm, flood, hail, tornado, weathering, acts causing personal injury, and any other injury or damages while vehicle is stored at Park Bark & Fly beyond the control of Park Bark & Fly. This storage agreement does not include storage insurance. The owner shall be responsible for insuring the vehicle and its contents while stored at Park Bark & Fly.

The following conditions must be met:

1. Notify Park Bark & Fly of any change of address, phone number, ownership of vehicle or any other pertinent information.
2. Park vehicle only in the space/lot assigned by Park Bark & Fly.
3. Vehicle must be in working order and with no flat tires while stored at Park Bark & Fly.
4. Vehicle must be lawfully licensed and titled at all times while stored at Park Bark & Fly.
5. Do not discard trash on the property of Park Bark & Fly.
